APS SOLAR COMMUNITIES PROGRAM



Solar energy is one of the most talked about topics in Arizona. And for good reason: it's clean and sustainable. However, for some it may not be an option. That's why we created the APS Solar Communities program. It gives limited- and moderate-income customers an opportunity to access solar. Qualifying single-family residences are invited to participate. View requirements below.

Participants will receive a monthly credit of \$30 on their energy bill for 20 years. The program is absolutely free to qualifying customers (see reverse side for details).

APS is committed to bringing affordable solar to more customers. And we need our customers' help to make it happen. We supply the solar panels, do the installation, and maintain the panels for the life of the program.

#### What type of homes qualify?

- Single-family homes with a west- or south-facing roof with little to no shade and in good condition that can accommodate a minimum of 14 solar panels.\*
- Mobile homes do not qualify.
- Manufactured homes need to meet "single-family" requirements and pass a review.
- Townhomes and condominiums need to meet "single-family" requirements and the owner must own the roof space.

YOUR ROOF MUST:

Have enough space that is west- or south-facing

Have little to no shading

Be in good condition

## Income verification process

To enroll in the program, participants can be registered in the APS Energy Support program (E-3), or verify their income. If on public assistance, an award letter from one of the following accepted public assistance agencies is acceptable:

- Supplemental Nutritional Assistance Program (SNAP)
- Temporary Assistance for Needy Families (TANF)
- Low Income Home Energy Assistance Program (LIHEAP)

Also accepted is verification from the income documents list below, showing at least one recent month's income for all adult members of your household (copies must be submitted for all adults living in the home):

- One month's worth of recent pay stubs
- W-2s for the past year
- Most recent year's Federal Tax Form 1040, 1040A or 1040EZ
- Most recent year's Federal and State income tax returns if self-employed
- Supplemental security income (SSI)
- Social security disability income
- Official child support or alimony award letters
- Veterans benefits
- Annuities
- Unemployment benefits
